Democracy is a synonym for the English word democracy which is made up of two words 'demos' and 'kratia'. On this basis, two types of democratic governance are considered (1) Direct democracy (2) Indirect democracy In direct democracy, the sovereign public directly participates in governance, determines policy, makes laws and appoints administrative officers to control them. Controls and in indirect democracy when the sovereign people themselves do not exercise this type of sovereignty directly but work through their representatives. In this, the public elects its representatives for a fixed period fixed by the constitution and these people's representatives work keeping in mind the interest of the public.

- Public infrastructure and utility
- Economic Governance
- Social Welfare and Development
- Judicial and Public Security
- Citizen centric governance etc. is important.
- Other areas related to agriculture business.

States and Union Territories are divided into four parts in the index

- Group -1
- Group 2
- North East Hill States
- Union Territories

According to the Good Governance Index, 20 states have improved their position and Delhi has secured the first position. The Good Governance Week was organized by the Department of Administrative Reforms and Public Grievances in collaboration with various Ministries on the theme of 'Administration Village'. In which good governance oath is also administered to the personnel. Madhya Pradesh has been ranked first in the country in the National Good Governance Index. The best personnel in the state are also rewarded. It is clear from the above description that in comparison to the previous years, there have been many improvements in the direction of establishing good governance. Still there is scope for more reforms which need to be done not only at the central level but also at the state level.⁴
